



Building Capacities of Training Schools and Institutes of Public Administration to implement the 2030 Agenda and attain the SDGs

Background

Many countries are quite advanced in implementing the 2030 Agenda for Sustainable Development, adopted by world leaders at the UN in September 2015, along with the 17 ambitious Sustainable Development Goals (SDGs) that are at its heart. Governments have been updating strategies and plans, organizing and mobilizing institutions and non-state actors, and developing systems for review and oversight.

Public servants have a key role in all those areas. They are also at the centre of delivering public services, which are instrumental for realizing many of the SDGs. Key principles of the 2030 Agenda such as integrated approaches or leave no one behind have deep implications for the way public institutions work. Critically, public servants form the backbone of such institutions, with the success of implementing the key principles of the 2030 Agenda resting on the ability of the public service to adapt to the changes in mindset required by the SDGs.

The implementation of the 2030 Agenda requires effective public management leaders that fully embrace the core values of the Agenda, such as collaboration and integration, leaving no one behind, inclusion, partnerships, respect for people and planet, integrity, transparency and accountability. The success in the implementation of the 2030 Agenda heavily depends on the capacity of public servants (in terms of knowledge, skills, attitude, leadership competencies and mindset) to support the implementation of the SDGs. To be up to the task of implementing the SDGs, new competences in the public sector are needed.

Public administration training institutions play a leading role in developing government competencies and promoting present and future capacities across ministries and institutions. To spearhead the implementation of the 2030 Agenda, the current government leadership and the next generation of public servants must internalize that development is not possible without peace and a mindset highlighting the principles and values of the 2030 Agenda. Leaders must have concrete practical tools to spearhead the transformation needed in the public sector to achieve the SDGs.

To contribute to developing the capacity of public servants to embrace the principles and values of the 2030 Agenda and the SDGs in their daily work, UNDESA, through its global initiative, is engaging with schools and institutes of public administration to mobilize and equip public servants for

implementing the 2030 Agenda for Sustainable Development and attain the SDGs as well as developing and updating their curricula to reflect the SDGs and the key principles and objectives of the 2030 Agenda.

The overall purpose of the initiative is to develop the capacities of public servants (in terms of knowledge, skills, attitude, leadership competencies and mindset) to support the implementation of the SDGs, provide data and information about the development of capacities in the regions; and support institutional capacity development for improved public service delivery as well as North-South and South-South exchange of effective governance practices to ensure cross-fertilization and mutual learning.

Against this backdrop, UN DESA's Division for Public Institutions and Digital Government, with the support of the 'Government for Citizens' Public Corporation" NJSC and in collaboration with UNDP, the Astana Civil Service Hub and the Academy of Public Administration under the President of the Republic of Kazakhstan, is organizing a workshop to build capacities of training schools and institutes of public administration to implement the 2030 Agenda and attain the SDGs.

The theme of the workshop builds on interest from a presentation by UN DESA/DPIDG at the Astana Economic Forum in May 2019, that introduced the UN DESA's Global Initiative on Equipping Public Servants with the Capacities to Implement the 2030 Agenda for Sustainable Development and achieve the SDGs. Furthermore, this workshop is a follow-up to the recommendations made during the Expert Group Meetings conducted by the DPIDG in Kampala, and Marrakesh in 2018, and the African Symposium in Addis Ababa in 2017. Also, during the recent Astana Economic Forum and the 27th Annual Conference of the Network of Schools and Institutes of Public Administration in Central and Eastern Europe (NISPAcee) participants requested to intensify transformational leadership capacity-development in institutes responsible for training public servants.

Objectives

The workshop aims to build the capacities of training schools and institutes of public administration to include in their training both the principles and the objectives of the sustainable development agenda. It will also aim to equip public servants with transformational leadership capacities needed to implement the SDGs. Strengthened capacities of the institutes and schools of public administration responsible for public servants' training will create a multiplying effect which will bring a greater impact on the development of the skills and competencies required for the achievement of SDGs.

This workshop will also provide an opportunity to include the 2030 Agenda and SDGs among the parameters for accrediting training programs in public administration and to place the training on the 2030 Agenda and SDGs on a sustainable footing.

Finally, the workshop will provide a platform for sharing expertise in training and education of public servants among participating countries and contribute to North-South and South-South cooperation.

Participants

The direct beneficiaries of the workshop are senior public service officials, national SDG focal points, as well as institutes of public administration and the public servants and leaders they train from Central Asia region, who will be supported in their efforts to integrate transformational leadership and the values and principles of the 2030 Agenda and the SDGs into their training programs.

Sponsored participants will be drawn from six countries, namely: Afghanistan; Kazakhstan; Kyrgyzstan; Uzbekistan; Tajikistan; and Turkmenistan. Several experts and human resource managers from the Netherlands, the United States, the United Arab Emirates, and Montenegro will participate, as resource persons, to provide substantive backstopping to the meeting. Engagement of the resource persons will enrich the discussions of the workshop.

Expected Outcomes

The workshop will allow participants to make proposals and recommendations on the next steps needed to strengthen public administration education and the capacity of training schools and institutes of public administration for the implementation of the 2030 Agenda. The participants will identify specific SDG-related competencies and mindsets from the Region that are needed for accelerating the implementation of the 2030 Agenda and realization of the SDGs.

In addition, through the interactive activities planned during the workshop and complemented by the plenary sessions, participants will gain an enhanced understanding of the need to develop and promote teachings of SDGs.

It is expected that, as a follow-up to the event, the participating training schools and institutes of public administration as well public servants will have:

- (i) Familiarised themselves with the notion of transformational leadership and the principles of the 2030 Agenda and the SDGs;
- (ii) Mainstreamed the SDGs in their training and capacity development programs. They will have also included the notion of transformational leadership, values, and principles of the 2030 Agenda in their curricula;
- (iii) Discussed and internalised the transformational competencies and mindsets required by public sector leaders and public servants for the achievement of SDGs;

- (iv) Improved their skills for considering SDGs in planning, monitoring and reporting;
- (v) Recognised the need for collaboration and partnerships among schools and institutes of public administration in developed and developing countries for sharing expertise in training and education of public servants.

A final report will be drafted at the end of the workshop. It will include working papers compiled for the workshop as well information on the educational and training materials, as well as information on the Curriculum on Governance for the SDGs, developed by UNDESA/DPIDG.
